Directions to 2010 PAT Sessions

*****All sessions begin promptly at 8:30 a.m.*****

America's Best Value Inn, 809 W Clairemont Ave, Eau Claire (formerly Quality Inn)

From I-94 W, take Exit 70 to US-53 N; from US-53 N/S, take Exit 87 to US-12 W; proceed about 3 miles and turn left onto Stein Blvd; immediately turn right onto the frontage road. Coming from the west, take Exit 65 and turn right onto WI-37 N; turn right onto US-12 E, right onto Stein Blvd, and right onto the frontage road; park on the east side of the hotel. Session is in the Rosewood Room.

Best Western Janesville, 3900 Milton Ave, Janesville

From I-90, take Exit 171A. Proceed north on WI-26 for 1/4 mile. Session will be held in the Grand Ballroom.

Carroll University, 100 N East Ave, Waukesha

From I-94, take Exit 295 and proceed south on Hwy F. Cross Moreland Blvd and continue on Hwy 18 west (North Ave and a one way). Stay in the left lane and turn left onto Barstow Street; follow Barstow to parking lots #9, #10, #11, or #12 (see separate PDF, 2010 Parking Map for Carroll University) and walk to the Campus Center. If you need to drop someone off closer to the session site, continue onto Barstow until it dead-ends; turn left onto College Ave, and the first left onto East Ave; the Campus Center is the first building on your right. Session is in the Ballroom (second floor).

Clarion Hotel, 626 W Pine St, Baraboo (formerly Park Plaza Baraboo)

From I-90/94, take Exit 92 onto US-12 south or, if coming from the east, Exit 106 onto WI-33 and proceed west to Baraboo. Clarion Hotel is located on the east side of US-12 (Pine Street) in Baraboo. Session will be held in the Banquet Room.

Hilton Garden Inn, 1355 West 20th Ave, Oshkosh (adjacent to EAA)

From U.S. 41, take Exit 116 and proceed east on Hwy 44. Turn right onto 20th Ave and go about 1/4 mile; the Hilton Garden Inn is on your right. Session will be held in the Banquet Room.

Holiday Inn-City Centre, 200 Main St, Green Bay

From US-41, take the WI-29 east exit (Shawno Ave); continue towards downtown (~3 miles) and turn left onto Ashland Ave. From Ashland, turn right onto Dousman St, continue over bridge (Dousman becomes Main St) and the Holiday Inn is on your left. Session will be held in the Banquet Room.

Kalahari Resort and Convention Center, 1305 Kalahari Dr, WI Dells

From I-90/94, take Exit 92 onto US-12 west (towards WI Dells). Proceed for about 2 blocks, turn right on Meadow View Dr, and another right onto Kalahari Dr.

Marathon County Extension Office, 212 River Dr, Suite 3, Wausau

From I-39/US-51, take Exit 192 (WI-29 W intersects with this Exit). Turn right (east) and proceed on Stewart Ave for about 1 1/2 miles until you cross a small bridge. Turn right onto River Dr and another right at the second building. Session will be held in Conference Rooms 1 & 2.

UW-Arlington Research Station, N695 Hopkins Rd, Arlington

From I-90/94, take Exit 119 (WI-60) and proceed east to US-51. Go south on US-51 for about 5 miles and turn right onto Badger Rd (a "UW Agricultural Research Station" sign is on your right). Proceed west for one mile to the Farm's Headquarters. Session will be held in the Public Event Facility (south of the main office).

UW-Stevens Point Campus, 800 Reserve Street, Stevens Point

From I-39/US-51, take Exit 159. Proceed west on WI-66 (Stanley Street) to Fremont (parking lot X will be in front of you). Turn left onto Fremont and right into Lot X (metered lot, 50¢ per hour). Session will be held in Room 122 of the College of Natural Resources Building.

Waukesha County Courthouse, 515 W Moreland Blvd, Waukesha

From I-94, take Exit 294 to CR-J south (Pewaukee Rd). Proceed about 2 miles and turn right onto Moreland Blvd. From I-43, take Exit 50 to WI-164 N (East Ave); turn left onto College Ave; right onto Barstow St; right onto Buena Vista; left onto Pewaukee Rd; and left onto Moreland Blvd. The visitor parking lot is on your right. Walk across Moreland to the Courthouse main entrance. Upon entering, you'll go through security screening. Afterwards, follow the signs into the Administration Center on your left. Session will be held on the ground floor, Rooms G55/G59.
